ORDINANCE NO. 706

AN ORDINANCE TO AMEND CHAPTER 1-5 AS IT RELATES TO MONTHLY SICK LEAVE ACCRUAL FOR MEMBERS OF THE FIRE DEPARTMENT; AND OTHER MATTERS PROPERLY PERTAINING THERETO.

The City Council of Boulder City do ordain:

SECTION 1. Section 1-5-11 of the City Code is hereby amended to read as follows and Subsections 1-5-11(A) and (B) are hereby affirmed:

"1-5-11: SICK LEAVE: Each permanent and probationary employee, Department Head and City Officer, but excluding the employees in the Fire Department, shall accrue the equivalent of one (1) working day's sick leave per month. Employees in the Fire Department shall accrue fourteen (14) hours of sick leave per month. Sick leave may be accumulative to a maximum of One Hundred Eighty (180) days (1,440 hours) for those employees working a five-day, forty-hour week and One Hundred Forty-Four (144) days (1,440 hours) for those employees working a four-day, forty-hour week. Employees in the Fire Department may accumulate sick leave to a maximum of One Thousand Nine Hundred Eighty (1,980) hours. Sick leave may be used in hourly increments.


SECTION 2. REPEAL OF CONFLICTING PROVISIONS: All other Code Sections, or portions of Code Sections; Resolutions, or portions of Resolutions; portions of ADMINISTRATIVE RULES AND REGULATIONS, and any other Manuals of Policy and Ethics as approved by the Civil Service Commission and the City Council, in conflict herewith are hereby repealed.

SECTION 3. VALIDITY: Each section and each provision or requirement of any section of this Ordinance shall be considered separable and the invalidity of any portion shall not affect the validity or enforceability of any other portion.

SECTION 4. EFFECTIVE DATE: This Ordinance shall become effective on the 19th day of August, 1981.

SECTION 5. EFFECT OF PASSAGE: Following the effective date of this Ordinance, the provisions herein shall be made retroactive so as to reflect that such changes had been in effect on July 1, 1981.

SECTION 6. PUBLICATION: The City Clerk shall cause this Ordinance to be published on Thursday, the 30th day of July, 1981 in the Boulder City News, a weekly newspaper published in Boulder City, Nevada.


