

ORDINANCE NO. 1651

AN ORDINANCE OF THE CITY COUNCIL OF BOULDER CITY, NEVADA TO AMEND TITLE 2, CHAPTER 5, SECTION 3 OF THE CITY CODE, DUTIES OF THE DEPARTMENT, BY ADDING A NEW DUTY (F.) CREATING A VOLUNTARY MOUNTED POLICE UNIT AND RENUMBERING F. OTHER DUTIES TO G

The City Council of Boulder City do ordain:

Section 1. That Boulder City, Nevada ("City") does by this Ordinance hereby amend Title 2, Chapter 5, Section 3 of the City Code as shown on the attached Exhibit "A".

Section 2. VALIDITY. Each section and each provision or requirement of any section of this ordinance shall be considered separable and the validity of any portion shall not affect the validity or enforceability of any other portion.

Section 3. PUBLICATION. The City Clerk shall cause this Ordinance to be published in summary on Friday, the 28th day of August 2020, in the *Las Vegas Review Journal*, a daily newspaper, published in Las Vegas, Nevada.

Section 4. EFFECTIVE. This Ordinance shall become effective, after its approval and publication, on the 17th day of September 2020.

Chapter 5 POLICE DEPARTMENT

2-5-1: DEPARTMENT CREATED:

There is hereby created the Police Department of the City. (Ord. 16, 12-28-1959, eff. 1-4-1960)

2-5-2: DIRECTOR:

A. Appointment: The department head of the Police Department shall bear the title of Director of the Police Department and Chief of Police. He shall be appointed by the City Manager.

B. Compensation: The salary of the Director of the Police Department shall be as set from time to time by the City Council. (Ord. 16, 12-28-1959, eff. 1-4-1960)

2-5-3: DUTIES OF DEPARTMENT:

The Police Department shall be generally responsible for the following duties:

A. Protection Of Property And Lives: The protection of the property of the City and the property and lives of the inhabitants of the City.

B. Enforcement Of Laws: The enforcement of the Constitution and laws of the State, the City Charter and the ordinances adopted by the City Council.

C. Crime Prevention Program: The adoption of a program for the prevention of crime, juvenile delinquency and traffic violation.

D. Respect For Law: A program designed to instill in the people of the City a respect for law and order and duly constituted authority.

E. Recruit, Train Volunteers: To recruit and train volunteer police officers to act as auxiliaries to the regularly appointed police personnel as may be approved by the City Manager.

F. Establish a voluntary Mounted Police Unit.

G. Other Duties: And all other duties properly pertaining to the above. (Ord. 16, 12-28-1959, eff. 1-4-1960)
