

ORDINANCE NO. 55

AN ORDINANCE OF THE CITY OF HAWAIIAN  
GARDENS RELATING TO THE STORAGE OF  
CERTAIN VEHICLES

THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS  
DOES ORDAIN AS FOLLOWS:

Section 125.5 is hereby added to the Hawaiian Gardens  
Zoning Ordinance, to read as follows:

Section 1. No portion of any required front yard  
area shall be used for the storage of motor vehicles (except  
automobiles in a fully operational condition) or trailers,  
(except trailers in a fully operational condition) or for the  
component parts of automobiles or trailers.

Section 2. No portion of any required front yard  
area shall be used for the storage of any building materials,  
(except building materials reasonably required for construction  
work on premises pursuant to a valid and existing building  
permit issued by the City of Hawaiian Gardens), except that such  
materials may be stored in such front yard area for a period  
of not to exceed thirty(30) consecutive days without such  
permit.

Section 3. The prohibitions relating to storage set  
forth herein shall apply to required side yards except when  
a fence has been legally constructed pursuant to City regulations  
of sufficient height and of a type which screens the stored  
property from public view and prevents it from becoming a  
nuisance by attraction to children.

Section 4. This ordinance shall not apply to any of  
the vehicles or articles described in Section 1. when the same  
is completely enclosed within a building or is being used in  
connection with a business enterprise lawfully situated upon  
the same premises and licensed to do business by the City of  
Hawaiian Gardens.

Section 5. "Storage" as used in this ordinance shall  
mean the physical presence of the vehicles or articles described  
in Section 1. of this ordinance, or any portion thereof,  
within the prohibited area as said area is defined in the  
Hawaiian Gardens Zoning Ordinance.

Section 6. Any person violating any of the provisions  
of this ordinance shall be guilty of a misdemeanor and upon  
conviction thereof shall be fined in an amount not exceeding  
Five Hundred Dollars (\$500.00) or shall be imprisoned in the  
County Jail for a period not exceeding thirty (30) days or be  
both ~~as fined~~ and imprisoned. Each day such violation is  
committed or permitted to continue shall constitute a separate  
offense and shall be punishable as such hereunder.

Section 7. If any section, sub-section, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not effect the validity of the remaining portions hereof.

Section 8. The City Clerk is instructed to certify to the adoption of this Ordinance and to cause the same to be posted in the manner required by law.
