

ORDINANCE NO. 66

AN ORDINANCE OF THE CITY OF HAWAIIAN
GARDENS ESTABLISHING REGULATIONS FOR
THE USE OF CITY PARKS

THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS DOES
ORDAIN AS FOLLOWS:

Section 1. The following sections are hereby added to the
Hawaiian Gardens Municipal Code:

Section 4167. Parks. Animals and Fowls. No person
within any public park shall, unless by written permission of
the City Clerk, hitch, fasten, lead, drive or let loose any
animal or fowl of any kind, provided that this shall not apply
to dogs when led by a cord, chain or lead not more than six
feet long.

Section 4167.1 Parks. Vehicles and horses. No person
within any public park shall, unless by written permission of the
City Clerk, ride or drive any horse or any other animal or drive
or propel any vehicle, motor scooter, motorcycle or bicycle
except in areas which may be specially designated for such
purposes.

Section 4167.2. Parks. Firearms and Fireworks. No
person within any public park shall, unless by written permission
of the City Clerk, carry or discharge any firearms, firecrackers,
rockets, torpedoes or any other fireworks, or airgun or slingshot;
provided, however, that such permits may only be issued for such
items as may be lawful under the laws of the State and the ordinances
of the City.

Section 4167.3 Parks. Injury to public property or plants.
No person within any public park shall, unless by written
permission of the City Clerk, cut, break, injure, deface or
disturb any tree, shrub, plant, rock, building, cage, pen,
monument, sidewalk, paved area, fence, bench or other structure,
apparatus or property; or pluck, pull up, cut, take or remove
any shrub, bush, plant or flower, or mark or write upon, paint or
deface in any manner, any building, monument, fence, bench,
sidewalk, paved area or other structure, or cut or remove any
wood, turf, grass, soil rock, sand, gravel or fertilizer.

Section 4167.4 Parks. Fires. No person within any public
park shall, unless by written permission of the City Clerk, make or
kindle a fire except in picnic stoves or fireplaces provided for
that purpose.

Section 4167.5 Parks. Camping or lodging. No person within
any public park shall camp or lodge therein, unless by written
permission of the City Clerk.

Section 4167.6 Parks. Cooking and Eating. Waste Liquids.
Garbage and Refuse. No person within any public park shall cook,
prepare, serve or eat any food except at places provided therefor,
or discharge any waste liquids, wash dishes or other utensils
elsewhere than in the sinks provided for such purposes or leave
garbage, cans, bottles, papers or other refuse elsewhere than in
receptacles provided therefor.

Section 4167.7 Parks. Games. No person within any public park shall play, practice or engage in any baseball, soft ball, football, socker ball, volley ball, golf, or other game excepting at such places as shall be especially designated or set apart for such purpose, unless by written permission of the City Clerk; provided, however, that nothing herein contained shall be construed as requiring such written permission for such informal games as "Catch", "Toss Ball", or other similar non-offensive games when participated in by not to exceed four persons when same are conducted in such a manner as not to disturb or annoy other persons present in such public park.

Section 4167.8 Parks. Boisterous and Indecent Conduct. No person within any public park shall indulge in riotous, boisterous, threatening, or indecent conduct, or abusive, threatening, profane, or indecent language, or operate any radio or musical instrument in such a manner as to disturb in any manner any picnic, meeting, services, concert, exercise or exhibition.

Section 4167.9 Parks. Handbills and Circulars. No person within any public park shall distribute any handbills or circulars, or post, place or erect any bills, notice, paper, or advertising device or matter of any kind, unless by written permission of the City Clerk.


Section 4167.10. Parks. Meetings. No person within any public park shall hold any meeting, service, concert, exercise or exhibition, unless by written permission of the City Clerk.

Section 4167.11. Parks. Model airplane flying. No person shall fly or cause to be flown, any model airplane, whether powered by a gasoline or electrical engine, or otherwise, within any public park, without written permission of the City Clerk.


Section 2. The City Clerk is instructed to certify to the adoption of this Ordinance, and to cause the same to be published or posted in the manner required by law.
