AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA AMENDING SECTION 2.08.040 OF CHAPTER 2.08 OF TITLE 2 OF THE HAWAIIAN GARDENS MUNICIPAL CODE PERTAINING TO COUNCIL REIMBURSEMENT.

THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Section 2.08.040 OF Chapter 2.08 of Title 2 of the Hawaiian Gardens Municipal Code is hereby amended to read as follows:

2.08.040 Councilmember and mayor expenses—Reimbursement.

Each member of the city council shall be reimbursed for actual and necessary expenses as fixed and determined by resolution of the city council, consistent with State Law and this Code.

SECTION 2. Effective Date. This Ordinance shall take effect thirty days after its adoption. The City Clerk or the City Clerk's duly appointed deputy shall certify to the adoption of this Ordinance and shall cause this Ordinance to be published as required by law.
