ORDINANCE NO. 4333

AN ORDINANCE OF THE CITY OF HASTINGS, NEBRASKA, AMENDING CHAPTER 32 OF THE HASTINGS CITY CODE PERTAINING TO THE BOARD OF PUBLIC WORKS; ADDING POSITIONS AND DELETING POSITIONS; PROVIDING AN EFFECTIVE DATE; AND REPEALING ANY ORDINANCES OR OTHER PROVISIONS IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HASTINGS, NEBRASKA:

<u>SECTION 1</u>. That Subsection 1 of Section 32-109 of the Hastings City Code is hereby amended to read as follows:

32.109. Employees; Powers Generally; Purchases.

(1) The following positions under the control of the Board of Public Works are hereby created and confirmed:

Accountant

Assistant Director of Electric Production

Assistant Manager of Utilities

Customer Accounts Supervisor

Customer Relations Coordinator

Director of Electric Production

Director of Engineering

Director of Finance

Director of Marketing & Energy Supply

Director of Operations

Electric Distribution Superintendent

Electrical Engineer

Energy Supply Analyst

Energy Supply Coordinator

Environmental Engineer

Environmental Supervisor

Gas Superintendent

Manager – Customer Accounting

Manager of Utilities

Mechanical Engineer

Project Coordinator – Electrical Production

Senior Energy Supply Coordinator

Substation & Communications Superintendent

Utilities Administrative Services Secretary

Wastewater Treatment Superintendent

Water and Sewer Superintendent

The Board is hereby empowered to employ persons for the above enumerated positions subject to the prior approval of the Mayor and Council in respect to job classifications and compensation ranges. The Manager of Utilities may, with the concurrence of a majority of the Board, retire or discharge any person holding any such position.

<u>SECTION 2</u>. Any ordinance passed and approved prior to the passage, approval and publication or posting of this ordinance and in conflict with its provisions is repealed.

<u>SECTION 3</u>. This ordinance shall take effect and be in full force from and after its passage, approval and publication or posting as required by law, in its entirety or in pamphlet form, as the case may be, said effective date being <u>January 1, 2013</u>, and this ordinance shall thereafter be included in the Hastings City Code book.

<u>SECTION 4</u>. The provisions of this ordinance are separable, and the invalidity of any phrase, clause or part of this ordinance shall not affect the validity or effectiveness of the remainder of the ordinance.
