**AN ORDINANCE TO ESTABLISH REFUSE RATES RELATED TO THE FRANCHISE AGREEMENT WITH REPUBLIC SERVICES, INC. FOR THE COLLECTION & DISPOSAL OF SOLID WASTE, RECYCLABLES, AND YARD WASTE FROM RESIDENTIAL PROPERTIES PURSUANT TO SECTION 55.12 OF THE CODIFIED ORDINANCES OF TIPP CITY, OHIO FOR A FIVE YEAR PERIOD ENDING ON SEPTEMBER 30, 2027.**

**WHEREAS**, the City Manager in May of 2022 advertised for competitive bids for the Collection & Disposal of Residential Refuse, Co-Mingled Recycling Collection, Co-Mingled Residential Refuse with Yard Waste, and Yard Waste Removal; and

**WHEREAS**, said bids were publicly opened and read aloud on June 10, 2022; and

**WHEREAS**, the bid submitted by Republic Services, Inc. was determined to be the lowest and best bid; and

**WHEREAS**, Republic Services, Inc. locally provides service to the City of Huber Heights, City of Clayton, and City of Riverside; now

**NOW, THEREFORE, The Municipality of Tipp City hereby ordains that:**

**Section 1.** Sections 55.29(G) and (H) of the Tipp City Code of Ordinances is hereby updated to reflect the rate schedule as submitted by Republic Services, Inc. for a five-year period. Monthly charges to be billed by the City as follows:

#### **SPECIAL HANDLING FEE FOR RESIDENCES ON CAYMAN CIRCLE (IF APPLICABLE)**

Note: Residences on Cayman Circle are currently special handled to keep the large packer-type truck off their communal driveway. The residents (through the homeowners association) may choose to ALL go to curbside collection at the rates specified above. If not, ALL of the residences serviced on Cayman Circle will be subject to the special handling fee below (i.e. the decision to collect in front of or behind the residential building must be the same across the entire residential area).



**Section 2.** That complete residential service shall be in accordance with Chapter 55 of the Tipp City Code of Ordinances, the contract between the City and Republic Services, Inc. and the Bid for Collection & Disposal of Residential Refuse, Co-Mingled Recycling Collection, Co-Mingled Residential Refuse with Yard Waste, and Yard Waste Removal dated June 10, 2022.

**Section 3.** That this Ordinance shall be in full force and effect from and after the earliest period allowed by law.
