AN ORDINANCE AMENDING TITLE 9 TRAFFIC CHAPTER 4 STOPPING, STANDING, PARKING AND ADOPTING THE REGULATORY TRAFFIC CONTROL SIGNAGE MAP

(Stop and Yield Signs)

WHEREAS, the Village of Oswego ("Village") has a population of more than 25,000 and is therefore a "Home Rule Unit" under the 1970 Illinois Constitution; and

WHEREAS, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license, to tax; and to incur debt; and

WHEREAS, the Village has in full force and effect a codified set of those ordinances of the Village which are of a general and permanent nature, which said codified set is known and designated as the Village Code of the Village of Oswego, as amended; and

WHEREAS, the Village intends to amend various sections of Title 9 Traffic; and

WHEREAS, the Village President (the "President" and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") find that the Text Amendment promotes the public health, safety, comfort, convenience, and general welfare; and

WHEREAS, the Corporate Authorities desire to grant the Text Amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OSWEGO, KENDALL AND WILL COUNTIES, ILLINOIS IN THE EXERCISE OF THEIR HOME RULE, STATUTORY AND OTHER POWERS, as follows:

<u>SECTION 1</u>: That the recitals set forth above are incorporated here by reference.

SECTION 2: Adoption of Oswego Regulatory Traffic Control Signage Map the Village of Oswego hereby adopts the "Regulatory Traffic Control Signage Oswego, IL" map dated February 4, 2025, attached hereto as "Exhibit A", as the official map designating locations of stop and yield control on the streets of Oswego.

SECTION 3: Amendment of Title 9, Chapter 4 Stopping, Standing, Parking Title 9, Chapter 4 Stopping, Standing, Parking of the Municipal Code of the Village of Oswego is hereby amended:

A. That Section 11 Two-Way Stops Designated is deleted in its entirety and replaced by the following:

Sec. 9-4-11. STOP CONTROL INTERSECTIONS DESIGNATED

- (A) Streets declared to constitute a two-way, three-way, and four-way stop in the village are designated on the "Regulatory Traffic Control Signage Oswego, IL".
- (B) The municipal authorities of the village are hereby authorized and required to place and maintain, or cause to be placed and maintained, appropriate signs as designated by the Village Engineer using engineering judgement; such signs to bear the word "STOP," and to be located in such position and to be provided with letters of a size to be clearly legible from a distance of at least 100 feet along the intersecting streets. All such signs shall be illuminated at night, or so placed as to be illuminated by streetlights, or by the headlights of approaching vehicles.
- B. That Title 9, Chapter 4, Section 12 One-way stops designated is deleted in its entirety.
 - A. That Title 9, Chapter 4, Section 13 Yield Intersections is deleted in its entirety and replaced by the following:

Sec. 9-4-13. YIELD INTERSECTIONS

- (A) Streets declared to constitute a yield intersection in the village are designated on the " <u>Regulatory Traffic Control Signage Oswego, IL".</u>
- (B) The Municipal authorities of the village are hereby authorized and required to place and maintain, or cause to be placed and maintained, appropriate signs as designated by the Village Engineer using engineering judgement; such signs to bear the word "YIELD" and to be located in such position and to be provided with letters of a size to be clearly legible from a distance of at least 100 feet along the intersecting streets. All such signs shall be illuminated at night, or so placed as to be illuminated by streetlights, or by the headlights of approaching vehicles.
- B. That Title 9, Chapter 4, Section 14 Four-way stops designated is deleted in its entirety.

C. That Title 9, Chapter 4, Section 17 Three-way stops designated is deleted in its entirety.

SECTION 4: SEVERABILITY

This ordinance and every provision thereof shall be considered severable. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 5: REPEALER

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

<u>SECTION 6:</u> EFFECTIVE DATE

This Ordinance shall be in full force and effect immediately upon its passage, approval and publication in this pamphlet form which is hereby authorized, as provided by law.
