

AN ORDINANCE REPEALING ORDINANCE NOS. 6406, 6808 AND 6890 AND APPROVING AND ADOPTING NEW ON-STREET PARKING TIME RESTRICTIONS

WHEREAS, the City of North Kansas City, Missouri (the “City”) is a body corporate, a third class city and political subdivision of the State of Missouri, duly created, organized and validly existing under and by virtue of the Constitution and laws of the State of Missouri; and

WHEREAS, the City manages use of the right-of-way, including managing space used for on-street parking, to provide for the public health, safety, and convenience; and

WHEREAS, the City’s adopted Master Plan, approved by the City Council on May 17, 2016, and adopted by the Planning Commission on June 2, 2016, recommended that the City manage parking, loading, and operations in the public right-of-way to encourage safety, economic vitality, and livability; and

WHEREAS, the City developed and adopted a Parking Management Plan approved by the City Council on September 19, 2018 and adopted by the Planning Commission on November 1, 2018, containing various strategies to build on downtown’s welcoming and inviting character, balance needs for parking with vibrant places for people, and make it easier for downtown patrons to find a parking space; and

WHEREAS, the Parking Management Plan recommends modifying on-street parking time limits to provide consistency for drivers, streamline enforcement, and support turnover of parking spaces; and

WHEREAS, the City requested feedback from area property owners and businesses regarding on-street parking time restrictions in blocks where changes were under consideration and presented that feedback to the City Council in a work session on January 15, 2019; and

WHEREAS, the City desires to revise the existing on-street parking time restrictions in certain blocks.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH KANSAS CITY, MISSOURI, AS FOLLOWS:

Section 1. **On-street Parking Regulations Established.** The City Council does hereby find and determine that it is in the best interest of the citizens of the City of North Kansas City, Missouri to modify, amend and update certain on-street parking time restrictions in the City. The City Council does, therefore, enact the following on-street parking time restrictions:

- A. All parking time restrictions on Swift Street between 12th Avenue and 13th Avenue be and hereby are removed.

- B. Parking on 20th Avenue between Burlington and Swift shall be and hereby is restricted to 2 hour parking between the hours of 8:00 a.m. and 6:00 p.m., excluding Saturdays, Sundays and legal holidays. It shall be unlawful to park any motor vehicle for more than two hours along 20th Avenue between Burlington and Swift as herein described.
- C. Parking on Swift Street, beginning immediately north of 21st Avenue and extending north approximately 165 feet shall be and hereby is restricted to 2 hour parking between the hours of 8:00 a.m. and 6:00 p.m., excluding Saturdays, Sundays and legal holidays. It shall be unlawful to park any motor vehicle for more than two hours along Swift Street immediately north of 21st Avenue approximately 165 feet as herein described.
- D. Parking on the east side of Fayette Street, beginning on the north side of Armour Road and extending north to the first alley north of Armour Road shall be and hereby is restricted to 2 hour parking between the hours of 8:00 a.m. and 6:00 p.m., excluding Saturdays, Sundays and legal holidays. It shall be unlawful to park for more than two hours along the east side of Fayette Street, beginning on the north side of Armour Road and extending north to the first alley north of Armour Road as herein described.

Section 2. Posting of Appropriate Signage. The Director of Public Works is hereby directed to erect and install appropriate signage advising the public of the parking restrictions at each of the locations described in paragraphs A through D of Section 1 of this Ordinance.

Section 3. Providing for Repeal of Conflicting Ordinances. Ordinance Nos. 6406, 6808 and 6890 are hereby repealed. All other ordinances or parts of ordinances in conflict with the provisions of this ordinance, or any parts hereof, are hereby repealed. Where appropriate, ordinances previously adopted are hereby amended to conform to the provisions of this Ordinance.

Section 4. Severability. The sections, paragraphs, sentences, clauses, and phrases of this Ordinance shall be severable. In the event that any such section, paragraph, sentence, clause, or phrase of this Ordinance is found by a court of competent jurisdiction to be invalid, the remaining portions of this Ordinance are valid, unless the court finds the valid portions of this Ordinance are so essential to and inseparably connected with and dependent upon the void portion that it cannot be presumed that the City has enacted the valid portions without the void ones, or unless the court finds that the valid portions, standing alone, are incomplete and are incapable of being executed in accordance with the legislative intent.

Section 5. Governing Law. This Ordinance shall be governed exclusively by and construed in accordance with the applicable laws of the State of Missouri.

Section 6. Effective Date. This Ordinance shall be in full force and effect, after compliance with all governing laws, rules, and regulations, upon passage by the City Council and approval by the Mayor.

- B. Parking on 20th Avenue between Burlington and Swift shall be and hereby is restricted to 2 hour parking between the hours of 8:00 a.m. and 6:00 p.m., excluding Saturdays, Sundays and legal holidays. It shall be unlawful to park any motor vehicle for more than two hours along 20th Avenue between Burlington and Swift as herein described.
- C. Parking on Swift Street, beginning immediately north of 21st Avenue and extending north approximately 165 feet shall be and hereby is restricted to 2 hour parking between the hours of 8:00 a.m. and 6:00 p.m., excluding Saturdays, Sundays and legal holidays. It shall be unlawful to park any motor vehicle for more than two hours along Swift Street immediately north of 21st Avenue approximately 165 feet as herein described.
- D. Parking on the east side of Fayette Street, beginning on the north side of Armour Road and extending north to the first alley north of Armour Road shall be and hereby is restricted to 2 hour parking between the hours of 8:00 a.m. and 6:00 p.m., excluding Saturdays, Sundays and legal holidays. It shall be unlawful to park for more than two hours along the east side of Fayette Street, beginning on the north side of Armour Road and extending north to the first alley north of Armour Road as herein described.

Section 2. Posting of Appropriate Signage. The Director of Public Works is hereby directed to erect and install appropriate signage advising the public of the parking restrictions at each of the locations described in paragraphs A through D of Section 1 of this Ordinance.






