ORDINANCE NO. 3027

AN ORDINANCE AMENDING TITLE 5 OF THE MUNICIPAL CODE OF THE CITY OF NORTH LAS VEGAS, RELATING TO MARIJUANA ESTABLISHMENTS; BY AMENDING CHAPTER 29, SECTION 5.29.140 (RETAIL MARIJUANA STORE OR MARIJUANA DISPENSARY-REQUIREMENTS AND LIMITATION), SUBSECTION G; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

NOW THEREFORE, the City Council of the City of North Las Vegas does ordain:

<u>SECTION 1</u>: Title 5, Chapter 29, Section 140, Subsection G of the North Las Vegas Municipal Code is hereby amended as follows:

- G. The following activities are prohibited for all licensed retail marijuana stores or marijuana dispensaries:
 - 1. The off-site retail sales of marijuana and marijuana products;
 - 2. The delivery of marijuana and marijuana products to the premises of any restricted or non-restricted gaming licensee;
 - 3. A retail marijuana store or medical marijuana dispensary shall not dispense or distribute, transfer or in any other way provide marijuana or marijuana products other than direct, face-to-face, in-person transfer to the holder of a registry identification card or designated primary, or persons 21 years of age or older with valid identification, while maintaining compliance with all applicable delivery and transportation regulations set forth in NRS 453A, NAC 453A, NRS 453D or NAC 453D. Marijuana shall not be provided by any other means of delivery including, without limitation:
 - a. Internet sales.
 - b. Except as otherwise permitted under this chapter, the transport, mail or private delivery of product.

SECTION 2: NON-INFRINGEMENT OF RIGHTS. The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges, or immunities secured by the laws providing for equal rights of citizens or persons.

SECTION 3: SEVERABILITY. If any section, paragraph, clause or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall in no way affect the validity and enforceability of the remaining provisions of this Ordinance.

SECTION 4: EFFECTIVE DATE. This Ordinance shall become effective after its passage by the City Council of the City of North Las Vegas and, after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of RS, as amended from time to time.

SECTION 5: PUBLICATION. The City Clerk shall cause this Ordinance, immediately following its adoption, to be published once by title, together with the names of the Councilmen voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.
