

ORDINANCE NO. 2893

AN ORDINANCE OF THE CITY OF NORTH LAS VEGAS AMENDING TITLE 15 OF THE NORTH LAS VEGAS MUNICIPAL CODE BY REPEALING EXISTING CHAPTER 15.16 OF THE MUNICIPAL CODE BY REPEALING ORDINANCE NO. 2660 AND BY ADOPTING THE UNIFORM PLUMBING CODE, 2018 EDITION AND THE SOUTHERN NEVADA AMENDMENTS TO THE 2018 UNIFORM PLUMBING CODE, WHICH CONFORM THE PLUMBING CODE IN NORTH LAS VEGAS TO SOUTHERN NEVADA PRACTICES, PROVIDE PENALTIES FOR THE VIOLATION THEREOF, AND PROVIDE FOR OTHER MATTERS PROPERLY RELATED THERETO.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH LAS VEGAS, NEVADA DOES ORDAIN:

SECTION 1: Ordinance No. 2660 and Chapter 15.16 of Title 15 of the North Las Vegas Municipal Code, which adopted the 2012 Uniform Plumbing Code with amendments, are hereby repealed.

SECTION 2: Title 15 of the North Las Vegas Municipal Code is hereby amended by adding a new chapter, designated as Chapter 15.16, which shall read as follows:

15.16.010 Adoption.

A. That certain document, one (1) copy of which is on file in the office of the City Clerk of the City of North Las Vegas, Nevada, which is marked and designated as the "Uniform Plumbing Code, 2018 Edition" published by the International Association of Plumbing and Mechanical Officials, together with all tables of contents, definitions, sections, tables, indexes, examples, and appendices, is hereby adopted and made a part of this chapter, the same as if it was fully set forth herein, except as amended by the "Southern Nevada Amendments to the 2018 Uniform Plumbing Code".

B. That certain document, one (1) copy of which is on file in the office of the City Clerk of the City of North Las Vegas, Nevada, which is marked and designated as the "Southern Nevada Amendments to the 2018 Uniform Plumbing Code" by Clark County, the City of North Las Vegas, the City of Las Vegas, Boulder City, the City of Mesquite, the City of Henderson, and the Clark County School District is hereby adopted and made a part of this chapter, the same as if it was fully set forth herein.

SECTION 3: NON-INFRINGEMENT OF RIGHTS. The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges, or immunities secured by the laws providing for equal rights of citizens or persons.

SECTION 4: SEVERABILITY. If any section, paragraph, clause, or provision of this Ordinance shall be held for any reason to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall in no way affect the validity and enforceability of the remaining provisions of this Ordinance.

SECTION 5: EFFECTIVE DATE. This Ordinance shall become effective after its passage by the City Council of the City of North Las Vegas and, after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.

SECTION 6: PUBLICATION. The City Clerk shall cause this Ordinance, immediately following its adoption, to be published once by title, together with the names of the Councilmembers voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.
