AN ORDINANCE AMENDING CHAPTER 2.06.020: MEETINGS OF THE WEST FRANKFORT CODE OF ORDINANCES FOR THE CITY OF WEST FRANKFORT

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/1-2-1, provides that the corporate authorities of each municipality may pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities, with such fines or penalties as may be deemed proper; and

WHEREAS, the City of West Frankfort is a home rule unit of government pursuant to Article VII, Section 6(a) of the Illinois Constitution and, pursuant to the provisions of said Section 6 of Article VII, may exercise any power or perform any function pertaining to its government and affairs; and

WHEREAS, the Illinois Municipal Code does not include any express limitation on the City's home rule authority as required by Article VII, Section 6 of the Illinois Constitution; and

WHEREAS, the City believes and hereby declares that it is in the best interest of the City to amend Chapter 2.06.020 of the West Frankfort Code of Ordinances entitled "Meetings" due to the change in time and location of City Council meetings since the ordinance was originally approved; and

WHEREAS, the City believes and hereby declares that it is in the best interest of the City to amend Chapter 2.06.020 of the West Frankfort City Code of Ordinances correct the location and time that City Council meetings are held under this section.

NOW, THEREFORE, be it ordained, by the City Council of West Frankfort, Illinois, as follows:

CHAPTER 2.06 – CITY COUNCIL

2.06.020 – Meetings.

The regular city council meetings of the City of West Frankfort shall be held twice per month, such meetings to be held on the second and fourth Tuesdays of each month at the hour of six (6) p.m. at West Frankfort City Hall located at 605 West Main Street, West Frankfort, IL 62896.
