ORDINANCE NO. TJ-4- 009

AN ORDINANCE PROHIBITING PARKING ON THE NORTH AND SOUTH SIDES OF ST. LOUIS STREET BETWEEN BRYAN STREET AND HORRELL AVENUE

WHEREAS, the City of West Frankfort, Illinois, is a home rule unit of government pursuant to Section 6, Article VII of the Constitution of the State of Illinois;

WHEREAS, the current unrestricted parking on the North and South sides of St. Louis Street between Bryan Street and Horrell Avenue is causing difficulty for those who are driving down St. Louis Street; and

WHEREAS, it is in the best interests of the City of West Frankfort that this Ordinance be adopted as it will provide for the general welfare of the City of West Frankfort.

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF WEST FRANKFORT, FRANKLIN COUNTY, ILLINOIS AS FOLLOWS:

Section 1. **PROHIBITED PARKING.** The following area shall be a No Parking area:

The North and South sides of St. Louis Street between Bryan Street and Horrell Avenue.

Section 2. **PENALTY.** Any violation of this Ordinance shall carry a \$ 50.⁰⁰ fine.

Section 3. **TOWING.** Any vehicle violating this Ordinance will be towed to the City impound lot and the vehicle will be responsible to pay towing charge of \$ 100.⁰⁰ and storage charges as they are assessed.

Section 4. **RECITALS AND FINDINGS.** All recitals and findings stated in the preamble are hereby incorporated herein.

Section 5. **REPEALER.** All ordinances, resolutions, orders, or parts thereof, which conflict with the provisions of this Ordinance, to the extent of such conflict, are hereby repealed.

Section 6. **SEVERABILITY.** If any provision of this Ordinance, or the application of any provision of this Ordinance, is held unconstitutional or otherwise invalid, such occurrence shall not affect other provisions of this Ordinance, or their application, that can be given effect without the unconstitutional or invalid provision or its application. Each unconstitutional or invalid provision, or application of such provision, is severable, unless otherwise provided by this Ordinance.

Section 7. **AUTHORITY.** The source of power for passing this ordinance is the home rule authority of the City of West Frankfort, Illinois and/or the Illinois Municipal Code.

Section 8. **FULL FORCE.** This Ordinance pertains to the government and affairs of the City, and due to its exigency shall be effective and in full force immediately upon its passage, approval and publication in accordance with law.


