

ORDINANCE NO.: 2019-7-15-D

**AN ORDINANCE AMENDING CHAPTER 5.08 ALCOHOLIC
BEVERAGE SALES**

**BE IT ORDAINED BY CITY COUNCIL OF THE CITY OF VANDALIA,
ILLINOIS:**

WHEREAS, the City of Vandalia controls the sale of alcohol beverages through Chapter 5.08, Alcoholic Beverage Sales; and

WHEREAS, the City of Vandalia recently had an individual renovate a business into an event center; and

WHEREAS, the definition of Event Center shall mean a facility designed and actually used, at least in part, for the purpose of accommodating public or private events, celebrations, parties, fundraisers, or other types of events for other individuals and/or groups. An event center shall not advertise the sale of alcoholic liquor anywhere on the licensed premises, either inside or outside.

WHEREAS, the Illinois Liquor Control Act and the Ordinances of the City of Vandalia authorizes the City of Vandalia to license and regulate establishments that sell and dispense alcoholic beverages.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY
OF VANDALIA, ILLINOIS:**

SECTION I: 5.08.060 Classification Fees.

A. There is hereby created Class K licenses which shall permit the retail sale of beer, wine and spirits in a licensed event center. A Class K license shall be issued subject to the following limitations:

- (1) Consumption of beer, wine and spirits is only allowed inside the licensed premises. No alcohol may be consumed outside the facility. Furthermore, no beer, wine or spirits may be sold in package form to be consumed elsewhere.
- (2) Beer, wine and spirits shall not be sold in pitchers.

- (3) Beer, wine and spirits shall be sold and served only during the permitted service hours as set forth in 5.08.150.
- (4) The annual fee shall be one thousand dollars (\$1,000.00).

SECTION II. This Ordinance shall be in force and effect 10 days from and after passage, approval, and publication.
