AN ORDINANCE SUPPLEMENTING CHAPTER 332 (VEHICLES AND TRAFFIC) ARTICLE IX (PARKING FOR THE DISABLED) OF THE JERSEY CITY CODE DESIGNATING A RESERVED PARKING SPACE AT VARIOUS LOCATIONS THROUGHOUT THE CITY.

COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:

1. Chapter 332 (Vehicles and Traffic) Article IX (Parking for the Disabled) of the Jersey City Code is hereby supplemented as follows:

Section 332-29	Disabled Parking Manual
Section 332-68	Parking for the disabled
Section 332-69	Restricted parking zones in front or near residences of disabled drivers

PARKING FOR THE DISABLED

Restricted parking spaces (measuring approximately 22 feet in length) in front of residential buildings for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles and handicapped parking permits issued by the Traffic Division.

4. This ordinance shall be a part of the Jersey City Code as though codified and incorporated in the official copies of the Jersey City Code.
