**AN ORDINANCE SUPPLEMENTING CHAPTER 332 (VEHICLES AND TRAFFIC) ARTICLE II (TRAFFIC REGULATIONS) AMENDING SECTION 332-8 (PROHIBITED RIGHT TURNS ON RED SIGNAL) AND ARTICLE III (PARKING, STANDING AND STOPPING) AMENDING SECTION 332-22 (PARKING PROHIBITED AT ALL TIMES) ON DUNCAN AVENUE BETWEEN ROUTE 1&9 AND WEST SIDE AVENUE**

**COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:**

- Chapter 332 (Vehicles and Traffic) Article II (Traffic Regulations) of the Jersey City Code is hereby supplemented as follows:

**Section 332-7           Prohibited right turns on red signal**

No person shall make a right turn when facing a steady red signal (stop indication) at any of the locations listed below.

<u>Lakeview Dr</u>	<u>North</u>	<u>Mallory Av/</u> <u>Duncan Av</u>	<u>All times</u>

- Chapter 332 (Vehicles and Traffic) Article III (Parking, Standing and Stopping) of the Jersey City Code is hereby supplemented as follows:

**Section 332-22       Parking prohibited at all times**

No person shall park a vehicle at any time upon any of the streets, or parts thereof, listed below:

Name of Street	Side	Limits
<u>Duncan Av</u>	<u>South</u>	<u>Route 1 &amp; 9 to Lookout Dr</u>

- All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- The City Clerk and the Corporation Counsel may change any chapter numbers, article numbers and section numbers if codification of this ordinance reveals a conflict between those numbers and the existing code, in order to avoid confusion and possible accidental repealers of existing provisions.
- This ordinance shall be a part of the Jersey City Code as though codified and incorporated in the official copies of the Jersey City Code.
