AN ORDINANCE SUPPLEMENTING CHAPTER 26 (VEHICLES AND TRAFFIC) AMENDING ARTICLE V (PARKING METERS) DESIGNATING AN ON-STREET PERMIT PARKING ZONE ON BOTH SIDES OF DOUGLAS AND ARTHUR SKINNER MEMORIAL DRIVE (FKA: JERSEY AVENUE) BETWEEN GRAND STREET AND THE SOUTHERN TERMINUS FROM 7:00 A.M. TO 3:00 P.M., MONDAY THROUGH FRIDAY; DESIGNATE METERERD PARKING ON BOTH SIDES OF DOUGLAS AND ARTHUR SKINNER MEMORIAL DRIVE BETWEEN GRAND STREET AND THE SOUTHERN TERMINUS FROM 3:00 P.M. TO 8:00 P.M., MONDAY THROUGH FRIDAY AND 9:00 A.M. TO 8:00 P.M.
