## **ORDINANCE NO. O-24-11-54**

### **AN ORDINANCE AMENDING ORDINANCE 74-07-21, CHAPTER 10, AN ORDINANCE REGULATING TRAFFIC**

**WHEREAS**, it has been determined by the President and Board of Trustees that it would be in the best interests of the public to amend the parking restrictions on Morris Avenue and Park Street; and

**WHEREAS**, the No Overnight Parking on the east side of Morris Avenue from Maple Avenue to a point 300 feet South of Maple Avenue shall remain in force; and

**WHEREAS**, the No Parking Anytime currently posted on the east side of Morris Avenue from Maple Avenue to Park Street shall be updated in the code and enforced; and

**WHEREAS**, the No Parking Anytime currently posted on the west side of Morris Avenue from Park Street to a point 300 feet north of Park Street shall be updated in the code and enforced; and

**WHEREAS**, No Parking Anytime shall be established on the South side of Park Street from the corner at Morris Avenue to 100 feet east of Morris Avenue from said intersection.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MUNDELEIN, COUNTY OF LAKE, STATE OF ILLINOIS** as follows:

**SECTION I.** Village Code 10.32.100 Article II Section 99 is amended for additional No Parking restrictions on Morris Avenue, replacing the entirety of the section with the restrictions as follows:

(a) No parking allowed between the hours of seven (7:00) PM and seven (7:00) AM daily on the east side of Morris Avenue from the intersection of Maple Avenue and Morris Avenue to a point three hundred feet south of Maple Avenue.

(b) No Parking anytime on the west side of Morris Avenue from Maple Avenue to Park Street.

(c) No Parking anytime on the east side of Morris Avenue from Park Street to a point 300 feet north of Park Street.

**SECTION II.** Permanent signs shall be installed on both sides of Morris Avenue containing the following: "No Parking Stopping or Standing 7:00 PM - 7:00 AM." for areas designated in Section I (a) hereto.

**SECTION III.** Permanent signs shall be installed on Morris Avenue containing the following: "No Parking Anytime Tow-Away-Zone" for areas designated in Section I (b) and (c) hereto.

**SECTION IV.** Village Code 10.32.100 Article II is amended to add a new section for additional No Parking restrictions on Park Street:

(a) No Parking Anytime on the south side of Park Street from the intersection of Morris Avenue and Park Street to a point one hundred feet east of Morris Avenue.

**SECTION V.** Permanent signs shall be installed on Park Street containing the following: "No Parking Anytime from Here to Corner" for the area designated in Section IV (a) hereto.

**SECTION VI.** In the event that any section, clause, provision or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in anyone or more of its severable applications, all valid applications that are severable from the invalid applications shall remain in effect.

**SECTION VII.** This ordinance shall be in full force and effect from and after its passage, approval and publication, as required by law.

**SECTION VIII.** This ordinance shall be published in pamphlet form and available in the Village Clerk's office.
