AN ORDINANCE AMENDING ORDINANCE NO. 04-12-69, AN ORDNIANCE REGULATING THE SALE OF ALCOHOLIC LIQUOR IN THE VILLAGE OF MUNDELEIN, ILLINOIS INCREASING THE NUMBER OF CLASS G LIQUOR LICENSES FROM SEVEN TO EIGHT

WHEREAS, the Mundelein Board of Trustees has determined that it would be in the best interest of the Village to increase the number of Class G liquor licenses from seven (7) to eight (8) for This Time Next Year, Inc., (d.b.a. Family Fishery), 412 N. Lake Street; and

WHEREAS, This Time Next Year, Inc. (d.b.a. Family Fishery), owned by Brendan Rafferty has been approved by the Village Police Department for a Village of Mundelein Class G liquor license (Restaurant beer and wine only, no bar).

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Mundelein, Lake County, Illinois, that:

SECTION I. Section 14 (G), License - Classification, Fees; Numbers; Hours; is hereby amended to increase the number of Class G licenses from seven (7) to eight (8), and shall henceforth read as follows:

- G. CLASS G LICENSE (Restaurant/Beer and Wine Sales Only), which shall authorize the retail sale in restaurants of beer and wine and no other type of alcoholic liquor, for consumption only at tables or booths on the licensed premise where sold. Consumption of beer or wine at or over a counter or bar is specifically prohibited on premises covered by a Class G license. Such license may be issued and retained by those establishments which:
 - (1) Have a seating capacity at tables and booths for a minimum of twenty-five (25) persons for food service;
 - (2) Are, in fact, operated and licensed as restaurants, as defined herein;
 - (3) Offer their patrons full and complete meals, including a dinner menu, and in which the serving of beer and wine is incidental and complementary to the service of such meals;
 - (4) Have no coin-operated amusement machines on the premises; and
 - (5) Class G license holders are not permitted to offer banquet services within the

licensed facility.

The annual fee for each license shall be One Thousand Five Hundred (\$1,500.00) and there shall be no more than a total of eight (8) Class G licenses outstanding and in force at any one time. A licensee which possesses a valid Class G license shall not serve, or offer for sale, beer or wine between the hours of 12:00 a.m. and 6:00 a.m. and shall not allow any beer or wine to be present on the tables or booths in the establishment between 1:00 a.m. and 6:00 a.m.

The term "full and complete meals, including a dinner menu" means food service provided by a licensee on the licensed premise on not less than five (5) days each week, between at least the hours of 5:00 p.m. and 8:00 p.m. continuously. Pizza, spaghetti, chop suey, and similar items, (but not sandwiches and snack-type foods), shall be considered a "full and complete meal."

SECTION II. Except as amended above, Ordinance No. 04-12-69, as amended, is hereby ratified, confirmed and approved.

SECTION III. Severability. If any section, clause, paragraph, or provision of this Ordinance shall be found invalid by a court of competent jurisdiction, such judgment shall not affect, impair, invalidate, or nullify the remained of the Ordinance, but only that part found invalid by such court.

SECTION IV. Effective Date. This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form as required by law.
