AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, REPEALING ORDINANCE NO. 1343, **AMENDING CHAPTER** 10.32 MUNICIPAL CODE RELATING TO SPEED LIMITS

WHEREAS, in accordance with California Vehicle Code Sections 22352, 22357, 22358, 40802, and related sections, (hereinafter referred to as the "Vehicle Code"), and in accordance with the State of California Manual on Uniform Traffic Control Devices, Part 2, Chapter 2B, Section 2B.13, (hereinafter referred to as the "MUTCD"), an Engineering and Traffic Survey, (hereinafter referred to as the "E&TS"), must be performed before the use of radar or other electronic devices is authorized for the purposes of regulating the speed of vehicles on certain streets or portions thereof; and

WHEREAS, on July 15, 2003, the City Council of the City of Rialto did adopt Ordinance No. 1343, establishing speed limits on certain City streets or portions thereof; and

WHEREAS, since the adoption of Ordinance No. 1343, the City Engineer has conducted and completed an E&TS on various City streets in accordance with the Vehicle Code and the MUTCD; and

WHEREAS, the results of the E&TS conform to the requirements of the Vehicle Code and the MUTCD and the results are required to be adopted by Ordinance; and

WHEREAS, the City's police officers' training and use of radar, laser, or other electronic devices used to measure the speed of vehicles comply with Section 40802(c)(1) of the Vehicle Code; and

WHEREAS, pursuant to Section 40802(c)(2)(B)(i), the speed limits to be established pursuant to this Ordinance shall be effective for 7 or 10 years, as the case may be, from the date of the E&TS, and the Public Works Director/City Engineer has concluded and recommends that the speed limits to be established pursuant to this Ordinance are justified.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY ORDAIN AS FOLLOWS:

Section 1: Ordinance No. 1343 is hereby repealed.

<u>Section 2</u>: Chapter 10.32 of the Rialto Municipal Code is hereby deleted and replaced with the following, to read in its entirety:

Section 10.32.010 State speed laws applicable.

The State traffic laws regulating the speed of vehicles shall be applicable upon all streets within this City, except as this Chapter 10.32, as authorized by State law, hereby declares and determines upon the basis of an Engineering and Traffic Study that certain speed regulations shall be applicable upon specified streets or in certain areas, in which event it is unlawful for any person to drive a vehicle at a speed in excess of any speed so declared in this Chapter 10.32 when signs are in place giving notice thereof.

Section 10.32.020 Increasing State speed limits in certain zones.

California Vehicle Code §22357 provides that a local authority may, by ordinance, determine and declare that the speed limit on any portion of any street, other than a state highway, which would otherwise be subject to a prima facie speed limit of 25 miles per hour shall be increased to a prima facie speed limit of 30, 35, 40, 45, 50, 55, 60, or 65 miles per hour, if an Engineering and Traffic Study indicates that such increase would facilitate the orderly movement of traffic and would be reasonable and safe.

It is hereby determined upon the basis of an Engineering and Traffic Study that the speed permitted by California Vehicle Code §22357 upon those streets or portions thereof identified in Section 10.32.050 is less than is necessary for safe operation of vehicles thereon by reason of the designation and signposting of said streets as through highways, or by reason of widely spaced intersections, and it is hereby declared that the prima facie speed limit upon those streets or portions thereof identified in Section 10.32.050 shall be as therein stated, which speeds so declared shall be effective when signs are installed giving notice thereof.

Section 10.32.030 Decreasing State speed limits in certain zones.

California Vehicle Code §22358 provides that a local authority may, by ordinance, determine and declare, that the speed limit on any portion of any street, other than a state highway, which would otherwise be subject to a prima facie speed limit of 65 miles per hour shall be reduced to a prima facie speed limit of 60, 55, 50, 45, 40, 35, 30 or 25 miles per hour, if an Engineering and Traffic Study

indicates that the prima facie speed limit of 65 miles per hour is faster than what is deemed reasonable and safe.

It is hereby determined upon the basis of an Engineering and Traffic Study that the speed permitted by California Vehicle Code §22358 outside of business and residence districts as applicable upon those streets or portions thereof identified in Section 10.32.050 is greater than is reasonable or safe under the conditions found to exist upon such streets, and it is hereby declared that the prima facie speed limit upon those streets or portions thereof identified in Section 10.32.050 shall be as therein stated, which speeds so declared shall be effective when signs are installed giving notice thereof.

10.32.040 Regulation of speed by traffic signals.

The City Engineer is authorized to regulate the timing of traffic signals so as to permit the movement of traffic in an orderly and safe manner at speeds slightly at variance from the speeds otherwise applicable within the district or at intersections, and shall erect appropriate signs giving notice thereof.

10.32.050 Prima facie speed limits established.

In accordance with Section 10.32.020 and 10.32.030, and when signs are erected giving notice thereof, the prima facie speed limit shall be as set forth in this Section upon the follow streets or portions of streets:
