

ORDINANCE NO. 2050

**AN ORDINANCE SETTING AND AMENDING CERTAIN FEES TO BE
CHARGED BY THE TEHAMA COUNTY CLERK-RECORDER**

THE BOARD OF SUPERVISORS OF THE COUNTY OF TEHAMA
ORDAINS AS FOLLOWS:

SECTION 1. The amounts set forth in the fee schedule entitled "Clerk-Recorder Fee Schedule (Partial)," a copy of which is attached hereto as Attachment "A" and is made a part hereof as though fully set forth herein, are hereby established as the fees for the designated services performed by the Tehama County Clerk-Recorder.

SECTION 2. This ordinance supersedes those portions of any prior ordinance or resolution setting any of the fees listed in Attachment "A," except for the previously established fees authorized by Government Code sections 27361, subdivision (d) and 27361.4, which are listed in Attachment "A" for reference purposes only.

SECTION 3. This ordinance shall not affect any fee that is not listed in Attachment "A."

SECTION 4. The Board of Supervisors hereby finds that the amounts set forth in Attachment "A" are reasonably necessary to recover the County's costs of providing the services described therein.




