

**ORDINANCE NO. 01628**

**AN ORDINANCE TO REDUCE SCHOOL RESTRICTED  
PARKING AREAS**

The Common Council of the City of Middleton do hereby ordain as follows:

1. Section 15.04(3)(a) of the City of Middleton Municipal Code is hereby amended to read as follows:

**(3) Restricted School Parking**

(a) No vehicle (except school buses, postal, delivery and utility vehicles parked in furtherance of their ordinary course of business) shall be parked between the hours of 7:30 a.m. and 4:30 p.m. on the following streets on days when public or private schools are in session and signs indicating such restrictions shall be erected in each area on said streets as follows:

Branch Street, east side, adjacent to Sauk Trail School property

Bristol Street, both sides, from Franklin Avenue north to the High School Property.

Bristol Street, west side, from University Avenue to Maywood Avenue

Clark Street, east side

Clark Street, west side

Deming Way, west side, adjacent to Primrose School

Donna Drive, south side, adjacent to Kromrey School property

Lee Street, north side, from Clark Street east to the High School Property

Middleton Street, both sides, from Franklin Avenue to North Avenue

Park Street, west side, from the centerline of Donna Drive to a point 585' south of the centerline of Donna Drive

Woodgate Road, south side, adjacent to Elm Lawn School property

2. Section 15.04(3)(a) of the City of Middleton Municipal Code as amended by this ordinance is hereby renumbered as Section 15.04(3).
3. Section 15.04(3)(c) of the City of Middleton Municipal Code is hereby repealed.

Lee Street, north side, ~~from a point 220' east of the centerline of Parmenter Street,~~ Clark Street east to the High School Property

~~Lee Street, south side, from Clark Street east to High School property~~

~~Maywood Avenue, north side, from Bristol Street to Park Street~~

~~Maywood Avenue, south side, from Bristol Street to Park Street~~

Middleton Street, both sides, ~~from North Avenue 150' north of to University Avenue~~ Franklin Avenue to North Avenue

~~North Avenue, north side, from Bristol Street to Park Street~~

~~North Avenue, north side, from Parmenter Street to the easterly property line of Fireman's Park~~

~~North Avenue, south side, from Bristol Street to Park Street~~

~~North Avenue, south side, from Parmenter Street to Middleton Street~~

~~Park Lawn Place, east side, from University Avenue to Maywood Avenue~~

~~Park Lawn Place, west side, from University Avenue to Maywood Avenue~~

~~Park Street, west side, from University Avenue to Maywood Avenue~~

~~Park Street, west side, from the centerline of Donna Drive to a point 585' south of the centerline of Donna Drive~~

~~Woodgate Road, south side, adjacent to Elm Lawn School property~~

2. Section 15.04(3)(a) of the City of Middleton Municipal Code as amended by this ordinance is hereby renumbered as Section 15.04(3).
3. Section 15.04(3)(c) of the City of Middleton Municipal Code is hereby repealed.
