### ORDINANCE NO. 2515

# AN ORDINANCE AMENDING SECTION 2-192(c), ENTITILED MANAGER AND PURCHASING AGENT AND CREATING SECTION 2-193 ENTITILED CITY ADMINISTRATOR, OF DIVISION 2, ENTITILED SPECIFIC OFFICERS AND POSITONS, OF ARTICLE III ENTITLED OFFICER AND EMPLOYEES, OF CHAPTER 2 ENTITLED ADMINISTRATION, OF THE MUNICIPAL CODE OF THE CITY OF CUDAHY CONCERNING THE REPORTING STRUCTURE FOR THE MAYOR AND CABINET OFFICERS

WHEREAS, The City of Cudahy intends to operate an efficient, responsive, and responsible City government, which provides a high level of service to City residents at a reasonable cost; and

**WHEREAS,** the operation of municipal government has become increasingly complex and expensive over time, due to continually changing laws and municipal obligations; and

**WHEREAS**, the Common Council for the City of Cudahy has authority under Wisconsin Statutes Section 62.11(5) and other laws to create the position of City Administrator and establish the qualifications, compensation and terms of employment for the position; and

**WHEREAS**, the Common Council of the City Cudahy intends that the position of City Administrator shall report to the Mayor, similar to the other Cabinet Officers of the City.

**NOW, THEREFORE,** the Common Council of the City of Cudahy, Milwaukee County, Wisconsin DOES HEREBY ORDAIN AS FOLLOWS:

**SECTION 1:** Section 2-192(c) entitled Manager and Purchasing Agent, of Division 2, entitled Specific Officers and Positions, of Chapter 2 entitled Administration, of the Municipal Code of the City of Cudahy is hereby amended to read as follows:

### Sec. 2-192(c) Manager

The mayor shall act as manager for the city.

**SECTION 2:** Section 2-193 entitled City Administrator, of Division 2, entitled Specific Officers and Positions, of Chapter 2 entitled Administration, of the Municipal Code of the City of Cudahy is hereby created to read as follows:

#### Sec. 2-193 City Administrator

- a) The City Administrator shall be appointed by the Mayor subject to approval by a majority vote of the total members of the Common Council.
- b) The City Administrator shall report to the Mayor.

- c) The City Administrator shall act as purchasing agent for the City Council and shall purchase all things necessary and as ordered by the Council in the open market not to exceed \$500.00 between regular Council meetings.
- d) The City Administrator shall perform such duties as directed by the Mayor.

# **SECTION 3: SEVERABILITY**

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

## SECTION 4: EFFECTIVE DATE

This ordinance shall take effect immediately upon passage and posting and/or publication as provided by law.
