#### **ORDINANCE NO. 21-2266**

## AN ORDINANCE AMENDING CHAPTER 7 ARTICLE 12 OF THE MUNICIPAL CODE OF THE VILLAGE OF BOURBONNAIS, ILLINOIS CONCERNING TIMING OF THE PAYMENT OF CERTAIN BUILDING PERMIT FEES FOR NEW RESIDENTIAL CONSTRUCTION

WHEREAS, the President and Board of Trustees (the "Corporate Authorities") of the Village of Bourbonnais, Kankakee County, Illinois, an Illinois municipal corporation, (the "Village"), desire to promote and encourage new residential construction in the Village; and

WHEREAS, the Corporate Authorities previously approved Ordinance 19-2140, and Ordinance 20-2202 amending permit fees, and the Corporate Authorities hereby find that the Village should continue the amendment of permit fees for an additional year; and

WHEREAS, the Corporate Authorities finds that residential growth is in the best interest of the Village; and

WHEREAS, the Illinois Municipal Code in general and more specifically in § 65 ILCS 5/11-30-4 authorizes the Village to set and control the construction of buildings; and

WHEREAS, the Corporate Authorities find and determine that it is necessary to provide an incentive to spur new residential construction; and

WHEREAS, the Corporate Authorities hereby find and determine that the powers authorized by §65 ILCS 5/11-31-1 imply and thereby grant to the Village authority to implement applicable statutes, codes and ordinances; and

WHEREAS, the Corporate Authorities determine that Chapter 7, Article 12 of the Code of Ordinances of the Village outlines the process and procedures for when permit fees are payable; and

WHEREAS, the Corporate Authorities of the Village find that it is necessary, appropriate and in the best interests of the Village and its citizens by temporarily amending this Section to allow the deferral of building and other fees for new residential construction to be payable at the time of Certificate of Occupancy or two (2) years from the issuance of the building permit, whichever is sooner. No other sections are hereby amended or altered. Said provision will remain in effect until December 31, 2021. At which time, the Village will revert back to the original language in Chapter 7, Section 12.

# NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BOURBONNAIS, KANKAKEE COUNTY, ILLINOIS AS FOLLOWS:

**SECTION ONE:** The foregoing recitals shall be and are hereby incorporated into and made part of this Section One as though they were fully set forth in this Section One.

**SECTION TWO:** Chapter 7, Article 12 shall be temporarily modified to allow the deferral of payment of building and other fees for permits issued for new residential construction between the effective date of this ordinance and December 31, 2021. Fees shall be payable to the Village at the issuance of the Certificate of Occupancy or two (2) years from the date of issuance of the building permit, whichever is sooner. This modification shall expire on December 31, 2021 and revert to the Chapter's original language.

**SECTION FOUR:** Should any provision or section of this Ordinance be declared invalid by any Court of competent jurisdiction; such declaration shall not affect the validity of this Ordinance as a whole or any part hereof other than the part so declared to be invalid.

**SECTION FIVE:** This Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law.
